VISA AND TRAVEL DOCUMENT REQUIREMENTS

All persons under 18 years old MUST travel with a certified copy of a full unabridged birth certificate and letters of consent signed by both parents. Certified copies of both parents ID's will also be required.

Participants travelling on a South African passport for tourism purposes qualify for the recently promulgated visa free travel regulation. This means no visa is required to enter Indonesia for a period of up to 30 days. Your passport needs to be valid for more than 6 months from date of entry and you will need a return air ticket and proof of accommodation (all included in the KSA travel package) for the duration of your stay.

TERMS AND CONDITIONS

BOOKING & CANCELLATION

A booking for a tour participant can only be made by completing and signing the tour booking form and returning it to Travel Airscape Group Tours (TAGT). Booking forms together with the required deposit payment will be accepted on a first-paid-first-served basis as seats on the tour are limited. A copy of the participant's valid passport or, if not yet available, identity document/birth certificate must be submitted with the booking form, so that travel insurance can be purchased. All cancellations must be made in writing and be delivered to TAGT's Weltevreden Park office. Deposits paid relating to written cancellations received by TAGT within five business days from original date of booking will be fully refunded unless cancellation date is within one month of departure in which case payments made are non-refundable.

TOUR PRICE

The tour price of R23990 per person is based on a minimum of thirty paying participants and includes the costs of three KSA official tour leaders. Should participant numbers be less than the minimum above, or should cancellations reduce the participant numbers below this number, TAGT reserves the right to cancel the entire tour, or should a majority of participants agree, increase the price accordingly. In the event that TAGT is forced to cancel the tour, non-cancelled participants will be refunded amounts paid less an administration fee, foreign exchange differences and non-refundable payments made to suppliers to secure travel services for the tour.

In order to keep prices as low as possible, prices do not include costs related to the form of payment used by participants – all such costs including bank charges and credit card fees are for the participants account. The tour price is based on current rates of exchange and current airport taxes. Currency fluctuations, airfare, airport taxes, hotelier, service supplier and other increases beyond TAGT's control may result in tour price increases (surcharges), which will be due and payable together with the final installment before travel documents will be released. TAGT and its agents, and teachers/leaders supervising the tour, reserve the right to make changes to the tour itinerary and content in the interests of personal safety or for reasons beyond their control. It is essential that participants check final documents and note and abide by all changes. The tour price includes comprehensive travel insurance, the details of which are available on request. Standard terms and conditions relating to such policies apply - attention is drawn to specific exclusions relating to pre-existing conditions. The sole onus is on each participant to ensure that they take out appropriate travel insurance cover for their circumstances, and confirm they are aware that they will be liable to pay any excesses that may be applicable relating to a claim.

PAYMENT, CANCELLATION AND LIABILITY

A non-refundable deposit of R110000 per person is payable by no later than 11 September 2015. The balance of payment is due by no later than 30 September 2015. Failure to make payment when due according to the payment schedule may result in the participant being removed from the tour at TAGT's sole discretion.

This payment schedule has been constructed to minimise price increases. Payments made to suppliers are made to contain price fluctuations as much as possible, and payments due by participants before written cancellation is received will not be refundable unless a substitute for the participant is found. No refund will be made for any unused services of any tour participant. TAGT acts only as agent for various principals, and does not accept liability for any loss or damage which any passenger may suffer as a result of the failure of principals and service suppliers to fulfil their obligations, whether in relation to travel arrangements or otherwise. Neither TAGT nor any person acting for it shall be liable for any loss, damage, accident, delay, death or inconvenience to any participant or his property. Each participant by his signature or that of his/her parents warrants that he/she specifically agrees to and accepts these terms and conditions, and has also made provision for full and proper financing and insurance to cover the costs of the tour, or any losses occasioned by his/her cancellation from the tour.

PASSPORTS AND VISAS

Each participant must be in possession of their own valid passport. Currently South African passport holders qualify for a visa free travel waiver to visit Indonesia for tourism purposes for a stay of up to 30 days. The arranging of all passports, visas and other travel documents such as unabridged birth certificates for minors and related letters and certified copies of parent/guardian identification documents or passports is solely the responsibility of the participant or his/her parents or guardians. All non-South African passport-holders may contact the issuing consulate or TAGT for assistance with regards to whether a visa is required.

GENERAL

All bookings made are in terms of this agreement, and no amendments will be binding unless reduced to writing and signed by a director of TAGT. The participant agrees to the jurisdiction of the Randburg Magistrates court in the event of a legal dispute, notwithstanding any issue relating to jurisdiction, and legal costs recoverable on an attorney and own client scale.
